## **Terms and Conditions of Board Membership**

### **Conflict of Interest**

Board Members must abstain from voting in possible conflict of interest situations, e.g. Board Members have an interest in or are members of the organization requesting funds, or where they are associated with any principals of the organization making an application to the Foundation.

### **Confidentiality Clause**

The applicant agrees to keep confidential, not to disclose to anyone, and not use in any way other than to carry out the duties of a member of a local Advisory Board, any and all information regarding TD Bank Financial Group and its affiliates, the Foundation, or local Advisory Board matters, made available to or obtained through being an Advisory Board Member unless is in the public domain or prior written approval is obtained from TD Bank Financial Group.

Examples of confidential information include but are not limited to, available funding amounts, information about TD Canada Trust customers, Foundation contributors, Foundation accounts, other Advisory Board Members, applications for funding, etc.

### **Identification of Board Members**

Applicant acknowledges that names of members of local Advisory Boards are required to be made available in the TD Canada Trust branch(s) within a local Advisory Board's geographical area. Further, applicant acknowledges that TD Bank Financial Group and/or the Foundation may in their discretion publish, publicize, or disseminate by various ways and means, information regarding a local Advisory Board and some one, or more of its members.
